The School-Based Coordinated Plan provides planning and resources for a variety of students and curriculum needs. Jackson Junior High has always provided a rich basic program: social studies, PE, special education, sixth grade math, science, technology, and consultant-assisted classes for reading excellence. The staff provides an integrated/inclusive curriculum, which serve our English learners as well as our lower-income, academically disadvantaged students identified under the federal Title I/No Child Left Behind (NCLB) programs. The regular curriculum is supplemented by the Accelerated Reader and Accelerated Math computer programs.

We emphasize strong support for students, English learners, and students scoring Below Basic and Far Below Basic on the California Standards Tests and below the 35th percentile on the state standardized tests.

We conduct fire, earthquake, and lock-down drills each month. The drills are discussed and procedures reviewed and changed as necessary.

New radios were purchased for better campus communication during all drills and on a daily basis.

We have developed emergency plans to deal with threatening situations. All staff members are part of the school Crisis Team. There is ongoing coordination between the principal, campus supervisor, counselor, and other staff.

All visitors and volunteers must sign in at the main office.

Admission Requirements for California Public Universities

University of California

Admission requirements for the University of California (UC) follow guidelines set forth in the Master Plan, which requires that the top one-eighth of the state's high school graduates, as well as those transfer students who have successfully completed specified college work, be eligible for admission to the UC. These requirements are designed to ensure that all eligible students are adequately prepared for University-level work. California State University

Admission requirements for the California State University (CSU) use three factors to determine eligibility. They are specific high school courses; grades in specified courses and test scores; and graduation from high school. Some campuses have higher standards for particular majors or students who live outside the local campus area. Because of the number of students who apply, a few campuses have higher standards (supplementary admission criteria) for all applicants. Most CSU campuses utilize local admission guarantee policies for students who graduate or transfer from high schools and colleges that are historically served by a CSU campus in that region.
