The district offers Sutter Creek Elementary qualified Gifted and Talented Education students the opportunity to work with certificated GATE instructor as well as contracted consultants. Students from grades 4-6 qualify for the G.A.T.E. program through a combination of norm-referenced test scores, teacher and parent referrals.

We receive unrestricted funds for ordinary expenditures such as salaries, staff benefits, books, supplies, equipment purchases, maintenance and repair of facilities and equipment, transportation costs, and utilities. A portion of this money also goes to the school's site budget and is spent at the discretion of the school's administration. Our principal makes these decisions in cooperation with the school staff.

We also receive funds from the state and federal programs that can be used only for specific purposes. These funds consist of the School and Library Improvement Block Grant, Arts and Music Block Grant, Economic Impact Aid, Discretionary Block Grants, Art, Music, and PE Block Grant, and GATE. Our School Site Council discusses and approves expenses from these accounts. Membership in the SSC is by election and includes school personnel, parent and community members.

They are specific high school courses; grades in specified courses and test scores; and graduation from high school. Because of the number of students who apply, a few campuses have higher standards (supplementary admission criteria) for all applicants. Most CSU campuses utilize local admission guarantee policies for students who graduate or transfer from high schools and colleges that are historically served by a CSU campus in that region.
