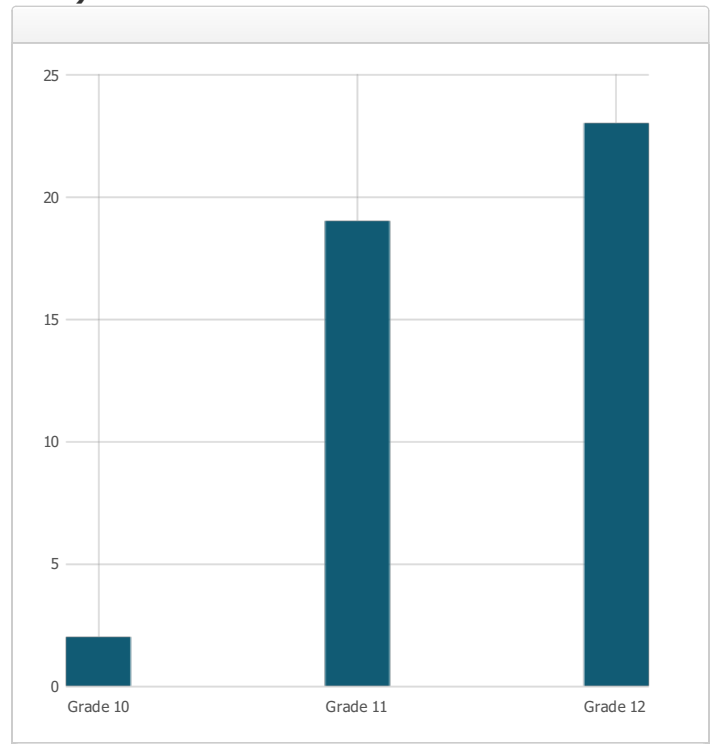
The mission of Independence High School is to provide each student with new opportunities and alternative ways to fulfill his or her unique potential.

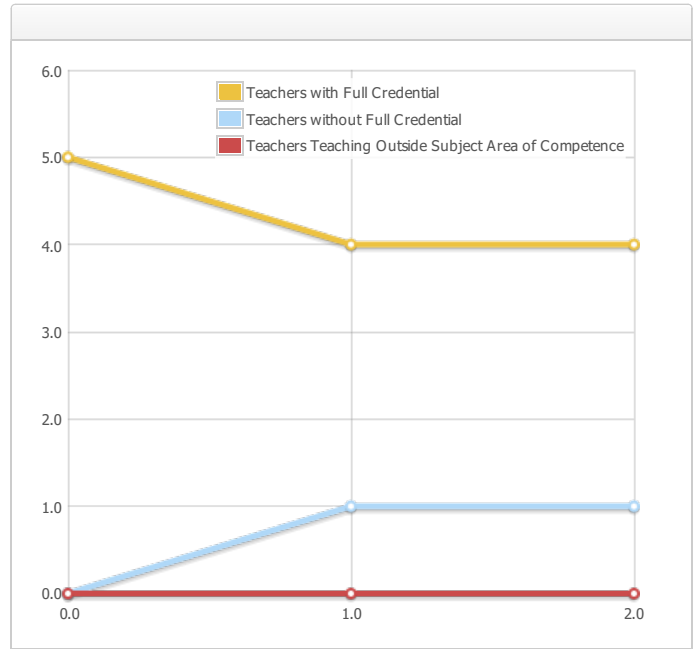

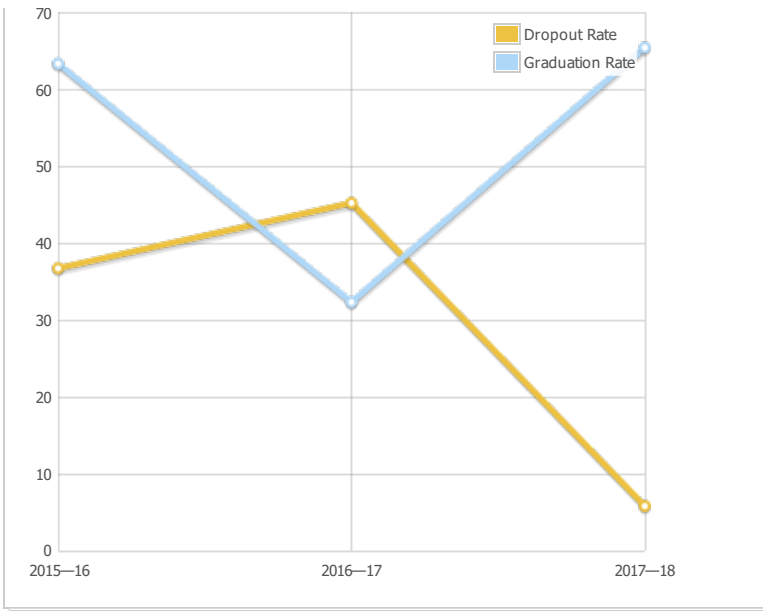

The 2015-2016 California budget introduced the Local Control Funding Formula (LCFF), dramatically reforming California's educational funding system.

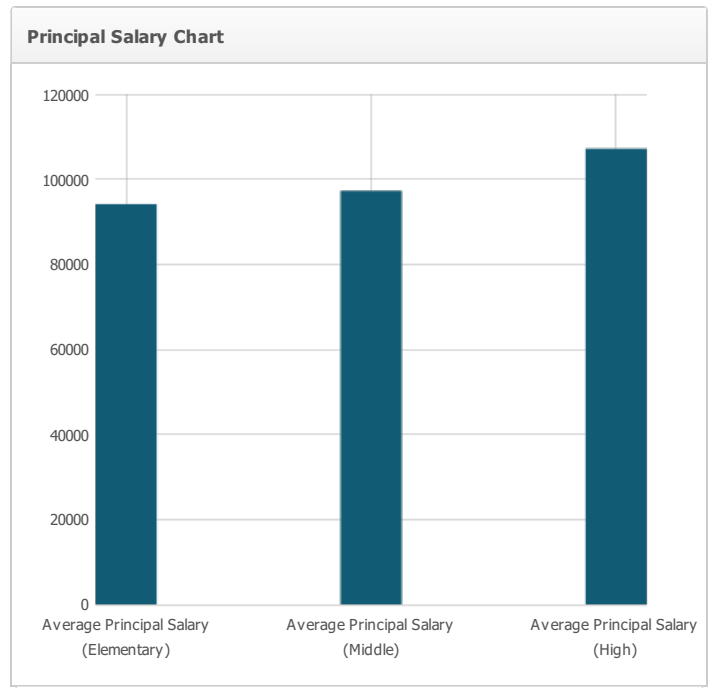
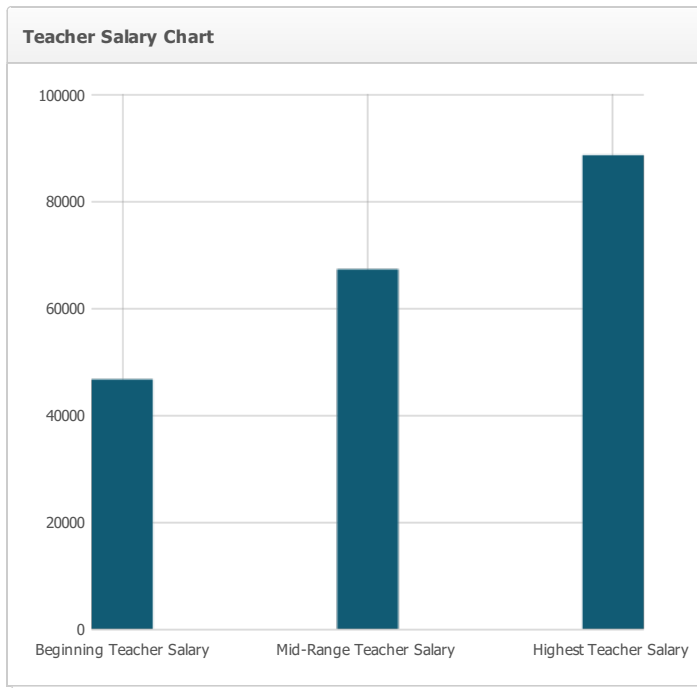
The LCFF eliminates most categorical funding streams, replacing them with funds based on each LEA's student demographic profile. The LCFF institutes a change in LEA accountability for unrestricted funding in the form of a three-year, annually renewed, Local Control Accountability Plan (LCAP). Currently we offer a broad array of support and intervention services, two online credit recovery programs and are switching to a project-based learning, Career Technical, integrated school program.
